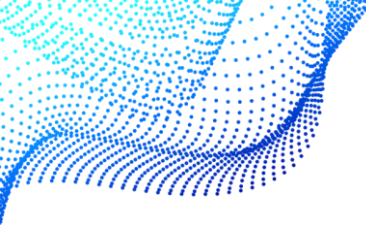

1. OPENING OF THE MEETING AND WELCOME

Prof. Henk Kummeling, CoARA Chair

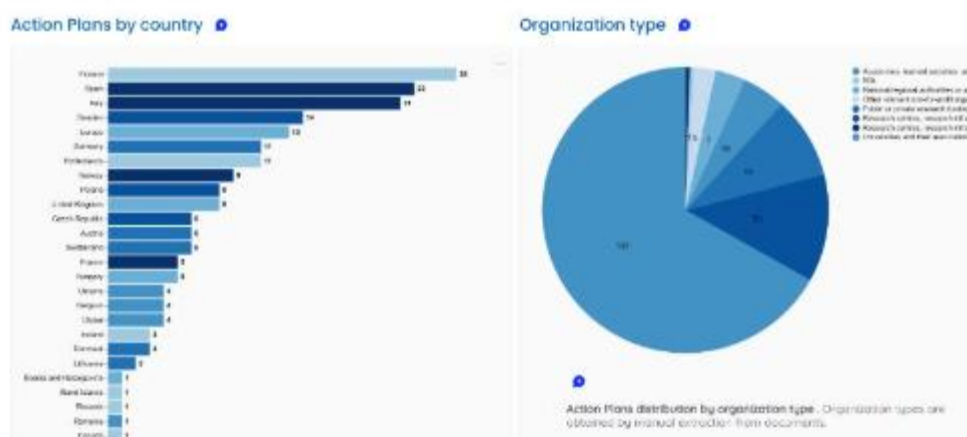

- **CoARA Boost – Outreach:** there has been a lot of CoARA related events, discussions and consultations in different national contexts in Europe and around the globe.
- **Action Plans:** they are the truest reflections of the systemic reform that is the mission of CoARA. However, their progress is slower than expected. The Coalition is strong and diverse, but the commitments of our members need to be implemented. Given the associated complexities, the Secretariat will provide enhanced support to members in developing and implementing their Action Plans.

From Agreement to Action: a bird eye's view



There have been no radical changes in the data since December 2024 in terms of the countries (Finland, Spain, Italy, Sweden) and the type of organisation (universities) that have submitted the most Action Plans.

Two platform have been created by the CNRS within the CoARA Boost Project. A lot of resources are available for Signatories and Members to rely on when building their Action Plan (guidelines, email help desk, webinars, support from National Chapters, etc.).

- **Working Groups:** their highlights can be found in the CoARA newsletter. A progress report published in March 2025 provides a consolidated overview of their work. A second call for Working Groups has been made in the spring of 2025, targeting 3 areas that haven't been extensively covered by the first generation of Working Groups, and are expected to start their operations in September 2025.

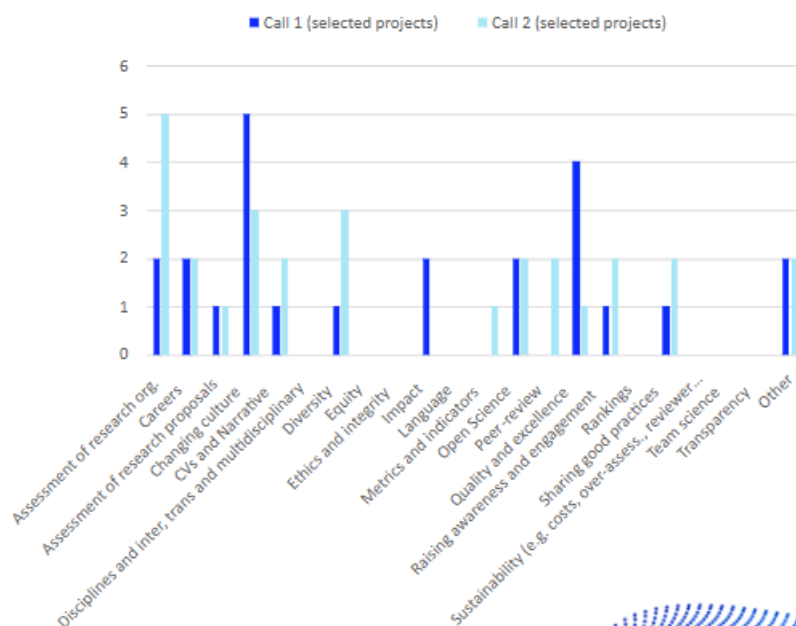


The Working Groups born from the first call have been granted the possibility to extend their operation for another year. Their proposals for extension are currently under Steering Board review, and the results will be communicated mid-July.

- **National Chapters:** two have been received in 2025 (from the Netherlands and Slovenia), which makes it 18 active National Chapters. An overview of the CoARA National Chapters is available in a [printable booklet](#). The second National Chapters Exchange Forum: “Defining Success,” was held in Bonn, Germany on 13-14 March 2025. The next one will be happening in Spain in March 2026.
- **Second Cascade Funding Call:** the high volume of good quality proposals (more than 140). Thanks to a pool of expert reviewers, 28 projects have been selected and are expected to start in September 2025.



The second pool of applications came from a wider range of diversity: organisation types, and they addressed a wider scope of interests. Please find the results here: [CF2 Selected Projects – CoARA](#).



- **Voluntary sponsorship campaign** was introduced in December 2024. The idea behind it is to reinforce the community ownership of CoARA and to build the capacity to carry out activities that the Coalition deems important, even beyond October 2026. The survey consultation was very successful and helped fine tune the framework of this campaign.

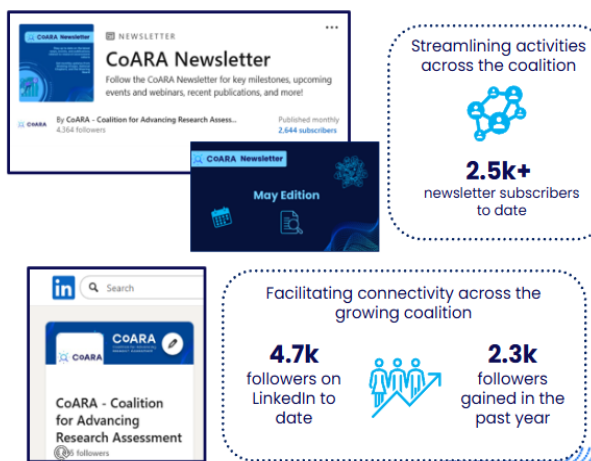

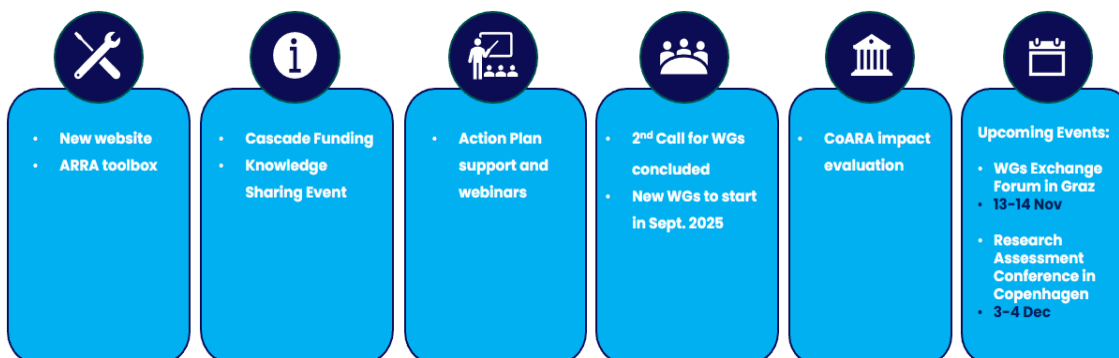

3. UPDATE OF THE COARA STEERING BOARD RULES OF PROCEDURE

Prof. Henk Kummeling, CoARA Chair

Prof. Henk Kummeling suggested to instigate a “knowledge transfer period” between incoming and outgoing Steering Board members. Accordingly, the Steering Board suggested an amendment to the [Rules of Procedure](#), which was submitted to a vote ([presentation slides 26-28](#)).

Proposed updates to the CoARA SB Rules of Procedure

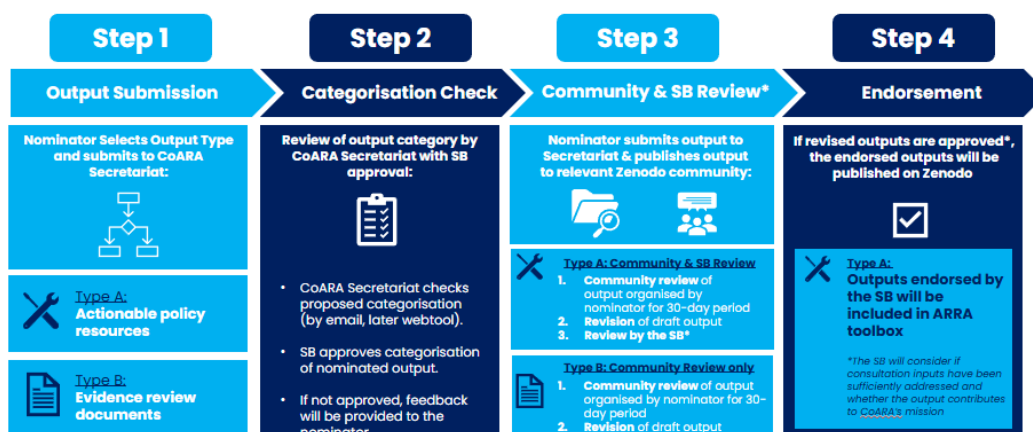
1. Arranging a knowledge transfer period across the leaving and coming Chairs, as well as across leaving and coming Steering Board members.
2. The new Chair begins their term upon announcing the election results. During the first three months of their operations, the leaving Chair is requested to support the work of the new Chair and ensure smooth knowledge transfer.
3. New Steering Board members begin their term upon announcing the election results. During the first two months of their operations, leaving Steering Board members are requested to support their work and ensure smooth knowledge transfer.

4. ENDORSEMENT FRAMEWORK FOR COARA OUTPUTS AND PRESENTATION OF THE ARRA TOOLBOX

Dr. Karen Stroobants, CoARA Vice Chair

Dr. Karen Stroobants presented the final version of the CoARA Outputs Endorsement Framework, which is a community-built mechanism aiming to establish a means to consider outputs, by the Coalition and external Third Parties, and build consensus around tools that support CoARA's commitments ([presentation slides 29-36](#)).

The final framework distinguishes between two types of outputs: Type A, comprising actionable policy resources, and Type B, encompassing evidence review documents. The endorsement process begins with a categorisation check and concludes with a community review for Type B outputs, or with both community and Steering Board review for Type A outputs. Once endorsed, the outputs will be deposited on Zenodo and included in the Toolbox.

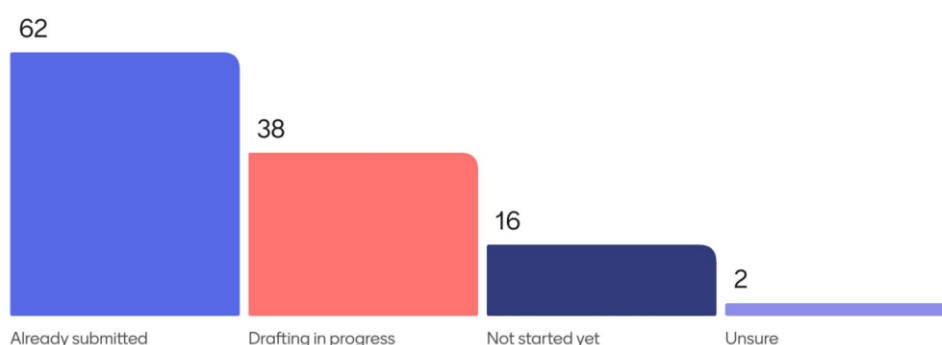

Question 1: What one word comes to mind when you think of your Action Plan progress?

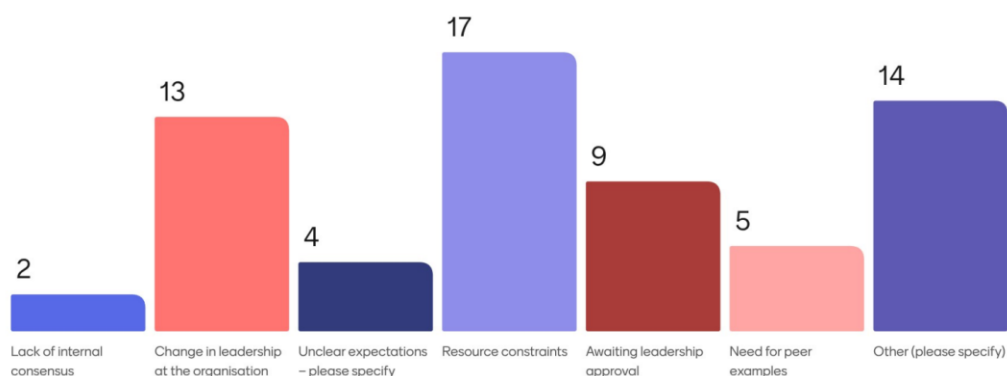

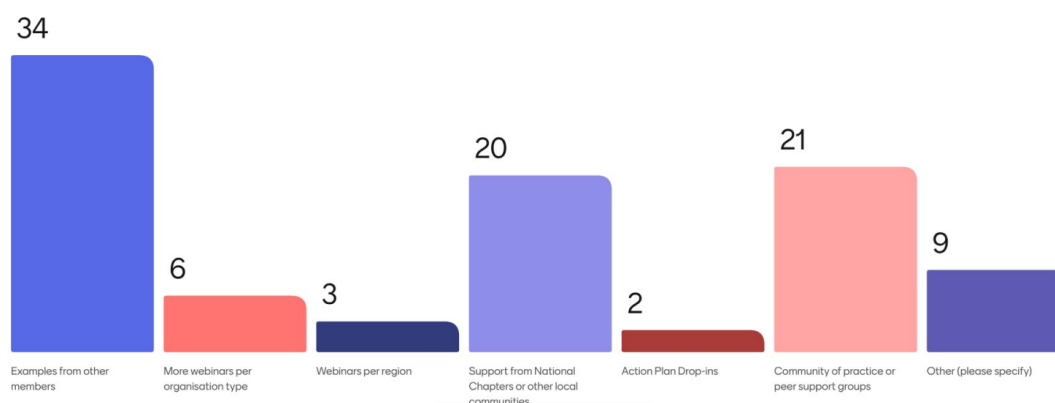
Question 2: What is your institution's current status regarding their CoARA Action Plan?



Question 3: If not yet submitted, what are the main reasons for the delay?

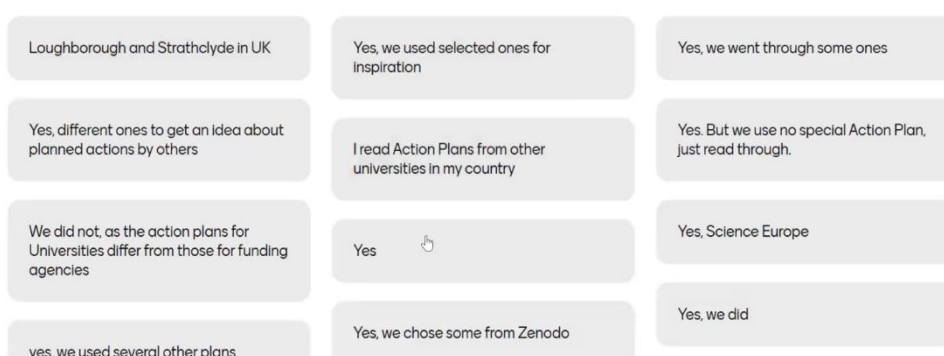


Question 4: What kind of support would help you progress with your Action Plan?

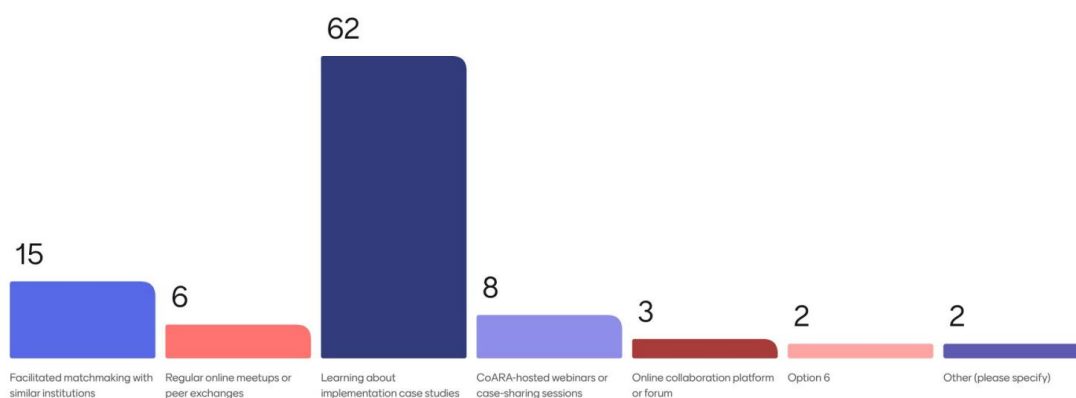


Question 5: Did you use other Action Plans to inform yours? Which ones?

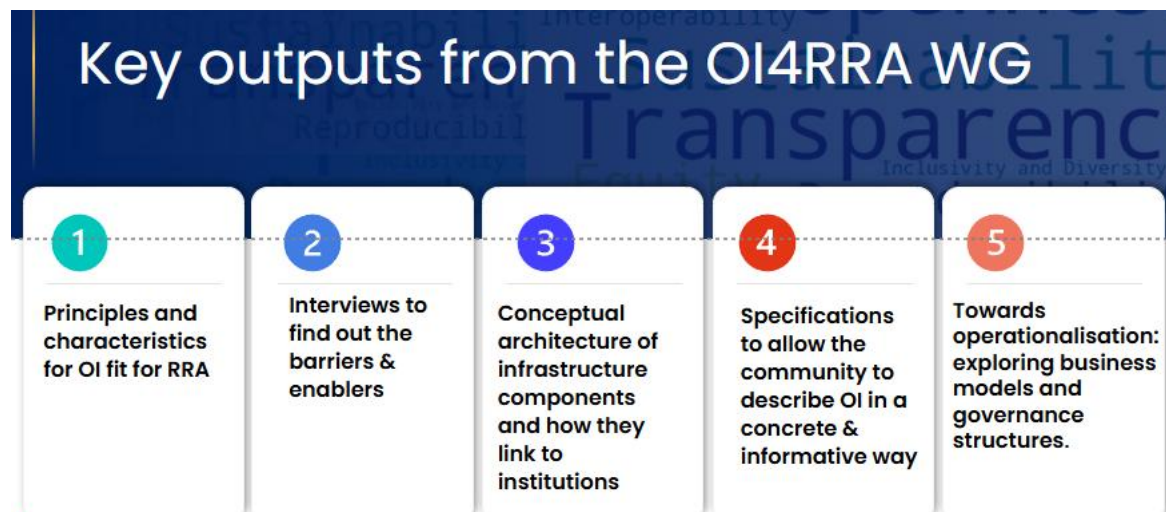
6. GUEST PRESENTATION: SHOWCASING WORKING GROUPS' OUTPUTS

Chaired by: Dr. Elizabeth Gadd, CoARA Vice Chair

Working Group "Towards Open Infrastructures for Responsible Research Assessment" (OI4RRA) – [Presentation slides](#).

Natalia Manola reminded participants that OI4RRA's mission is to support institutions in transitioning from proprietary infrastructure and research information systems to open, interoperable alternatives. It also seeks to take into account the wide range of research outputs and open science practices, reflecting the diversity of the research community.

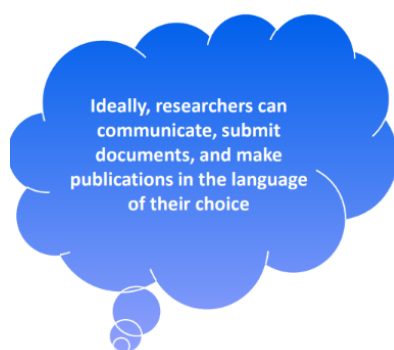

Janne Pölönen began by reminding participants that signatories of the CoARA Agreement are committed to recognising the broad diversity of research contributions, regardless of language, and to moving away from language-based metrics. The Multilingualism Working Group's mission is to support institutions in upholding linguistic equity, diversity, and non-discrimination in Europe and beyond.

The first objective is to raise awareness of the importance of multilingualism in the practice of science, in scientific publications, and in academic communication. The second objective is to provide practical guidance on recognising contributions regardless of language and on avoiding language bias in assessments.

The Working Group's landscape analysis has included the development of definitions and glossary literature, surveys of organisations and researchers, and the analysis of bibliometric databases. A report presenting this analysis will be published in 2025 and is expected to be included in the ARRA Toolbox

Aim

Understand drivers and barriers to research assessments reforms

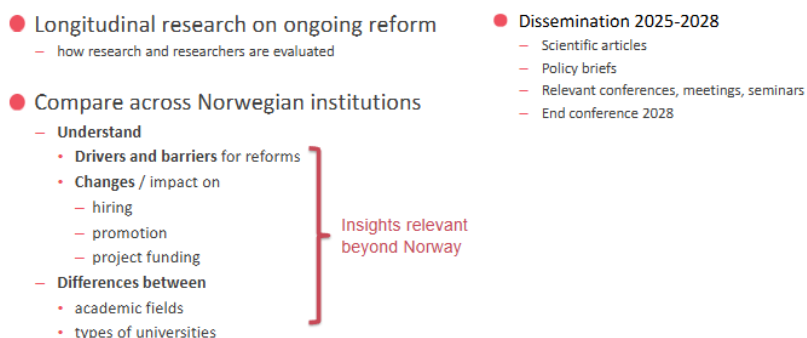
Research Questions

1. What are the CoARA-motivated **changes** implemented in Norway?
2. What are the **objectives** of the changes?
3. What effects (if any) do **reviewers** experience from e.g. new CV requirements or new review guidelines? Do they **change assessments practises**?
4. What effects (if any) do different groups of **applicants** (*gender, field, age*) anticipate from e.g. new CV requirements or review guidelines? Do anticipated effects **influence their research activities**?
5. What is the potential of CoARA-motivated changes to **impact the Norwegian research system**? How?
6. What are the **drivers and barriers** for (such) changes, and how do drivers and barriers **vary** between research fields, and between organisations or levels in organisations?

Prof. Liv Langfeldt emphasised that there are various entry points for understanding the reform of research assessment: the processes through which notions of research quality develop and become institutionalised; the reward and incentive systems within science; the norms that research assessments are expected to uphold; perceptions of what is at stake in reform processes; and the role of quantitative indicators in peer review.

The project comprises two work packages: the first focuses on the employment and promotion of academic staff, while the second examines the assessment of research grant proposals at the Research Council of Norway and at Foundation Dam.

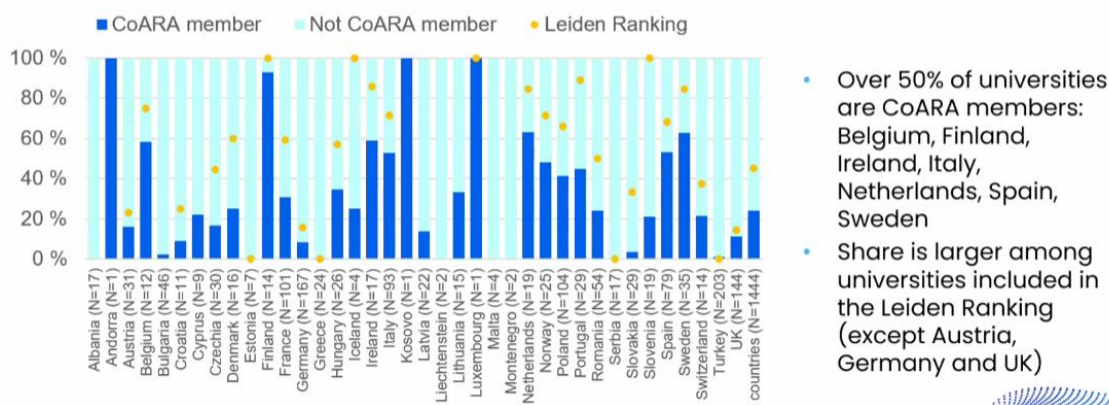
• Uptake of CoARA across the Higher Education Institutions in Europe

Janne Pölönen, Federation of Finnish Learned Societies, CoARA SB member

Janne Pölönen began by reminding participants that there are significant differences in the number of CoARA member organisations across countries in

Europe and globally, as well as among different types of organisations. The aim of this work is to develop a deeper understanding of these discrepancies in CoARA uptake by focusing specifically on Higher Education Institutions (HEIs) in Europe.

— Share of CoARA members: European PhD awarding institutions



This work highlights several issues for consideration:

- HEI landscapes are highly diverse and difficult to compare.
- A relatively small proportion of HEIs (13%) are CoARA members, although the share is higher among PhD-awarding institutions (24%) and among universities included in the Leiden Ranking Open Edition (45%).
- Uptake increases with institutional size and is more common among public organisations.
- There are marked differences in engagement between CoARA and other research assessment initiatives, such as DORA and HR Excellence.
- To gain a fuller understanding of the complexities surrounding CoARA uptake, there is a need for more qualitative, contextualised, and in-depth studies of individual countries and institutions.

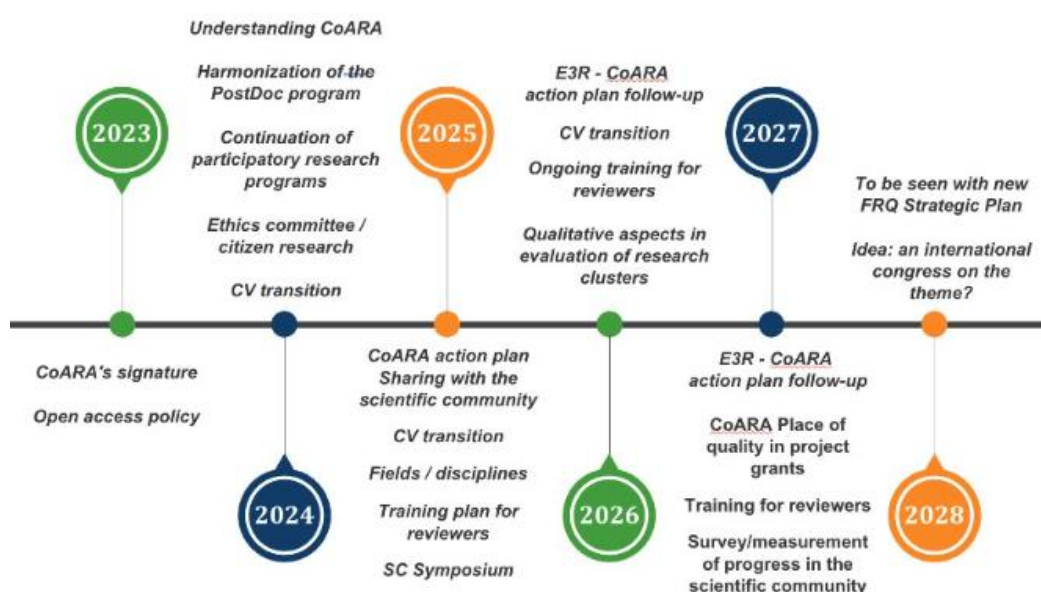
8. GUEST PRESENTATION: GLOBAL PERSPECTIVES ON RESEARCH ASSESSMENT: CANADA

Prof. Rémi Quirion, Network for Governmental Science Advice (INGSA)

Prof. Rémi Quirion's presentation focused on the implementation of the Fonds de recherche du Québec's Reform for Research Assessment (the Fonds de recherche du Québec being Québec's main research funding agency).

He emphasised that the reform of research assessment seeks to align evaluation practices with evolving societal priorities, increasing interdisciplinarity and intersectorality, emerging research forms, societal impact, transparency, and accountability.

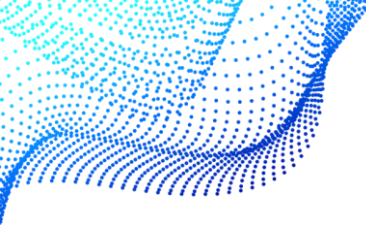
The FRQ's Action Plan centres on recognising diverse forms of contribution, strengthening qualitative assessment, training and supporting evaluators, and fostering continuous dialogue. The example set by the FRQ could encourage other organisations in North America to join CoARA.



9. GUEST PRESENTATION: EVALUATION OF RESEARCH PROPOSALS: RECENT CHANGES AT THE ERC

Angela Wittelsberger, Ph.D.

Angela Wittelsberger's presentation ([presentation slides 44–51](#)) began by focusing on how the European Research Council has recently modernised its understanding of excellence in the evaluation of research proposals. She explained that ERC proposals continue to be judged on excellence—defined by creativity, originality, and potential for significant advances in knowledge—and that no structural or procedural changes have been introduced. However, some terminology has been



revised: for instance, “high-risk/high-gain” has been replaced by “ambitious”, “creative”, and “original”.

She also noted that the development of novel methodologies has been removed from the evaluation questions, and that greater emphasis is now placed on the excellence of the project itself rather than on past achievements.

Modernisation of ERC’s understanding of excellence – main principles for evaluating the applicant

- **No prescriptive Principal Investigator profiles in Work Programme**
- Simplification of CV and track record documentation
- Allowing researchers to provide narrative descriptions of their work
- Room for explaining career breaks or unconventional career paths
- Room for describing contributions that go beyond standard academic duties
- Extramural funding not an evaluation criterion
- Supervision of graduate student or post-docs not an evaluation criterion

10. WRAP-UP AND CONCLUSIONS

Prof. Henk Kummeling concluded the General Assembly by expressing his pleasure at hearing about many interesting developments both within and beyond CoARA. He emphasised that outstanding work has been accomplished by numerous contributors, and he extended particular thanks to the guest presenters for their valuable contributions.

Finally, he announced that the quorum for the vote had been reached and that the proposed amendments to the Rules of Procedure and the Endorsement Framework had been adopted.

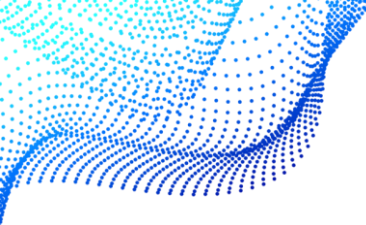
